

**CITY OF MITCHELLVILLE
REGULAR COUNCIL MEETING MINUTES
JULY 19, 2010 7:00 P.M.**

Mayor Wieslander called the meeting to order at 7:00 p.m.

Motion by Scott to approve agenda with changing items 3E, 3F, 3G, and 3H to items 9, 10, 11, and 12 respectfully, seconded by Olson. Roll call vote, Ayes: all. Motion carried.

Motion by Scott to approve consent agenda to includes items 3A, 3B, 3C and 3D as follows: claims for payment \$39,823.85, Minutes of Regular City Council meeting July 6, 2010; Tree Board July 13, 2010 Minutes; Planning & Zoning Commission July 13, 2010 Minutes, seconded by Thomas. The following list constitutes the official street tree species for the City.

Motion by Olson to approve Resolution 2010-22 transfer from Water Fund to Debt Service for Debt service payment on Water GO loan, seconded by Thomas. Roll call vote, Ayes: all. Motion Carried.
